

PhD SCHOLARSHIPS AT CREST

The Center for Research in Economics and Statistics (CREST) is offering PhD scholarships. These scholarships finance either the preparation of a PhD thesis (duration three years), or a finishing thesis (duration one year). They correspond to a gross monthly payment of 1 753.93 €.

They concern :

- Students from the ENSAE and ENSAI to conduct their research at CREST, or in any other research institution, in either France or foreign country.
- External students to conduct their research in one laboratory of the CREST.



The following topics will be privileged :

ECONOMICS : Labour Economics, Economics of Education, Urban Economics, Economics of Development, Environment, Macroeconomics, Growth Theory, Economic Fluctuations, International Economics, Monetary Economics, Public Economics, Theories of Employment and Unemployment, Industrial Organization, Contract Theory, Game Theory, Corporate Finance, Regulatory Economics, Competition Policy, Innovation Theory, Economic Policy Analysis, Randomized Experiments.

FINANCE-INSURANCE : Financial Econometrics, Econometrics of Insurance, Risk and Portfolio Managements, Regulation, Ratings and Credit Scoring, Corporate Risk, Longevity Risk and Pension Funds, Market Finance, Financial Economics, Banking Theory, Role of Intermediaries, Microstructure, High Frequency Data, Dynamic Modeling ,Systemic Risk, Speculative Bubbles, Scenario Generators, Monte-Carlo Methods, Analysis of Web Data, Web Insurance.

STATISTICS: High-Dimensional Statistics, Statistical Learning, Nonparametric Statistics, Bayesian Statistics and Simulation Methods, Compressed Sensing, Functional Data Analysis, Dimension Reduction, Statistical Inference for Stochastic Processes, Theoretical Econometrics, Survey Theory.#
